FIRE CHIEF REPORT

Fire Chief Bill Ford, III, presented the report:

- 1. A quote from Larry McGuire of \$200 was presented. It was to replace the sinks in the Fire House bathrooms. *Motion* by Mr. Whitt and second by Mr. Darbyshire to accept the quote. All voted yes. Motion passed.
- 2. Items to be purchased for the State EMS Priority One grant were presented. Funds have to be expended and reimbursement requested from the state by December 31, 2017. The grant is for \$5,625.
- 3. Archie Spangler, III, and Xavier Holland were recommended for admittance to the EMS department. *Motion* by Mr. Darbyshire and second by Mr. Whitt to accept the recommendation of the Fire Chief. All voted yes. Motion passed.
- 4. Permission to apply for the Marcs Radio grant was requested. *Motion* by Mr. Darbyshire and second by Mr. Whitt to permit the Fire Chief to apply for the grant; deadline for application is 11/18/17. All voted yes. Motion passed.
- 5. Cost of the Fire and EMS alumni dinner, to be held on 11/5/17, is estimated to be \$2,000. ½ of funds will come from the township treasury and the other half will be paid by the Fire and Rescue Association.
- 6. Twin Township now meets all qualifications to be considered a C.E.U. training site for EMS certification requirements.
- 7. Additional parking space for the Fire Department was discussed. President Mike Whitt appointed a committee consisting of Fire Lieutenant Bill Ford, Jr. and Trustee Bryan Bethel to investigate the options and present them at a later Trustee meeting.
- 8. A table for use at the Fire House has been purchased by the Fire Chief. *Motion* made by Mr. Whitt and seconded by Mr. Darbyshire to reimburse the cost upon presentation of a receipt to the Fiscal Officer. All voted yes. Motion passed.
